1. **General Information**

- 1.1 Name of Institution: Holland International School Limited
- 1.2 Location: 65 Bukit Tinggi Road, Singapore 289757
- 1.3 Course Dates and Hours: The Dutch Saturdays lessons operates every two weeks on Saturdays from 9:30am -12:00pm, starting on 10.1.2026 and ending on 6.6.2026, unless otherwise stated.

2. **Enrolment and Registration**

- 2.1 Enrolment for the Saturday School is open to students of 3-5 years of age and 6-10 years of age.
- 2.2 All students must complete the application form and submit the required documents, such as proof of identification and any other necessary medical or emergency information, prior to the commencement of classes, to languagegroup@hollandinternationalschool.sg
- 2.3 The signatory-page is to be signed in hard copy and submitted in scanned format.
- 2.4 Registration is subject to availability and is confirmed upon payment of the course fee.

3. **Fees and Payment**

- The course fee is \$1215 (inclusive of GST) per student, which includes resources, materials and 3.1
- 3.2 Payment must be made 30 days prior to the start of lessons.
- Fees are non-refundable except in cases where the course is cancelled by the school. 3.3
- 3.4 There will be no pro-rata refund for missed classes.

4. Class Schedule and Attendance

- 4.1 Classes will be held on Saturdays as per the agreed schedule.
- 4.2 Students are expected to attend all classes. If a student will be absent, parents or guardians must inform the school at least 24 hours in advance via email.
- 4.3 If the school cancels any class, it will notify parents and students in advance and make arrangements for a make-up session if possible.
