6. Children registered at Preschool will **automatically move up** to Primary School. You will be offered the choice for the Dutch Stream group 1 or the Reception Class at the English Stream, subject to availability and the Dutch/English language competence of the child. If you wish to withdraw your child from Holland International School Limited, you have to submit the deregistration form to the admissions office in accordance with the withdrawal dates as stated in the fee structure.
7. Students at Holland International School Limited can only start and continue to attend classes, if they hold a valid Dependent Pass or Student Pass or have a re-entry permit.
8. Where a child holds Singaporean citizenship, either by birth or registration, this information **must** be declared at the time of application. Singapore citizens holding dual citizenship may not apply based upon a non-Singaporean status.

Applicants, who hold Singapore citizenship, will only be able to start at our school after the Ministry of Education has issued a waiver. The school will apply for a waiver on behalf of the applicant.

Students who become Singapore citizens after joining the school will only be able to retain their place after the Ministry of Education has issued a waiver.
